

## **Court Requires EPA Review of Incineration MACT Standards**

In late August, a federal court ordered U. S. EPA to review its methodology for the air emissions standards promulgated in February, 2011 in new sewage sludge incineration (SSI) rules under the Clean Air Act. The National Association of Clean Water Agencies (NACWA) and Sierra Club had brought the court action for different reasons. According to a <a href="newsreport">news report</a>, the court found that EPA's process of setting the new Maximum Achievable Control Technology (MACT) numerical standards - extrapolating from a sample of just nine sewage sludge incinerators and applying other assumptions - was flawed. However, the court left the current standards in effect, even as EPA reviews them. For additional background, see past NEBRA news.
